SECOND STEERING COMMITTEE MEETING - Strasbourg, 17-18 March 2014

Operational conclusions

The partners of the EU/CoE Joint Programme « Strengthening democratic reform in the Southern Neighbourhood » (South Programme), on the occasion of the Second Steering Committee meeting (agenda and list of participants attached), adopted the following operational conclusions.

The partners :

- 1. Welcomed the achievements of concrete results since the beginning of the Programme's implementation, in the different components (Justice reform, Promotion of good governance, Human rights/Prevention of trafficking in human beings and Promotion of democratic values).
- 2. Considered that a reinforced political dialogue with relevant beneficiary countries, providing a support at high level to co-operation activities, will be beneficial for the South Programme and will facilitate the operational implementation of the commitments and reforms supported by the South Programme.
- 3. Took notes of the conclusions and recommendations of the mid-term evaluation prepared by IBF International Consulting at the request of the European Commission, which highlights the Programme's relevance and sustainability as well as the efficiency in its implementation.
- 4. Welcomed the expertise that the CoE puts at the disposal of the beneficiaries as well as the responsiveness and flexibility to reply to their demands.
- 5. Decided to continue involving closely civil society in Steering Committee meetings and, when appropriate, in the Programme's activities, considering the fundamental role of civil society in the democratic reform process in partner countries.
- 6. Took notes of the different initiatives undertaken in the framework of the South Programme to promote the exchange of experiences and the setting-up of networks between Southern Mediterranean countries and underlined their wish to continue strengthening South-South co-operation. In this respect, they also stressed the opportunity to further involve other African countries in order to deal in an appropriate

way with certain themes which go beyond the geographical scope of the Programme (e.g. trafficking in human beings).

- 7. Stressed the need to implement the Programme's actions as a part of a comprehensive approach (« holistic approach ») and considered, in this respect, that it would be appropriate to further strengthen synergies among the different components.
- 8. Recalled the need to ensure complementarity among the actions of different donors.
- 9. Endorsed the orientations presented during the meeting regarding the activities proposed for 2014, while stressing that the Programme remains flexible, in order to continue providing replies to the demand of partner countries.
- 10. Invited beneficiary countries which have not yet done so to designate a contact person as soon as possible.
- 11. Undertook to implement the recommendations of the Steering Committee meeting in their respective areas of work.
